Sir,

I am directed to invite applications for filling up 3 (three) post of Assistant Commissioner (NRM/RFS) in the pay scale of Rs. 15600-39100/- with Grade Pay Rs. 6600/- (pre-revised Rs. 10000-15200/-) in the Ministry of Agriculture, Department of Agriculture and Cooperation. Details of the post, eligibility conditions etc. are given in Annexure I. The pay of the officers selected for appointment on deputation basis shall be regulated in terms of DoP&T's O.M. No. 2/08/97-Estt.(Pay.II), dated 11.03.1998 as amended from time to time.

2. Applications of only such officers/candidates will be considered which are routed through proper channel and are accompanied by (i) Bio -data (in triplicate) as in the proforma given in Annexure II (ii) Photocopies of ACRs for the last five years attested by an officer not below the rank of Under Secretary to the Government of India (iii) Vigilance Clearance/Integrity Certificate and (iv) statement giving details of major or minor penalties imposed on the officer, if any, during the last 10 years.

It is, requested that applications of suitable and eligible officers who can be spared immediately in the event of selection may be sent to Under Secretary (Pers.II), Department of Agriculture and Cooperation, Ministry of Agriculture, Room No. 37-A, Krishi Bhawan, New Delhi-110001 within a period of **60 days** from the date of publication of this circular in Employment News.

4. Advance copies of applications or received after the prescribed closing date or not accompanied with the required certificates/documents are liable to be rejected.



4. Pay Scale: Rs. 15600-39100/- with Grade Pay Rs. 6600/- (pre-revised Rs. 10000-15200/-)
5. Age limit: The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

Eligibility Conditions:- Officers of the Central/State Government/Union Territories/Public Sector Undertakings/Autonomous or Statuary Organizations/ Semi Government/Agricultural Universities/Recognized Research Institutions or Councils possessing the following service, educational qualifications and experience, are eligible:-

Service:- (a) (i) holding analogous post on regular basis in the parent cadre/Department; or (ii) with 5 years service in the grade rendered thereto after appointment thereto on a regular basis in the scale of pay of Rs. 8000-13500/- or equivalent in the parent cadre/Department; and (b) possessing the following educational qualifications and experience:-

Essential:-

(i) Master's degree in agronomy or agriculture with agronomy as a subject or Agricultural Chemistry or Soil Science or Agricultural Extension or Agricultural Economics or Agricultural Botany/ Botany or Forestry or Degree in Agricultural Engineering of a recognized University or equivalent

(ii) Five years experience in a supervisory capacity in the field of Soil and water Conservation or Land Reclamation including Water Harvesting and farm Development.

Note:- The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

7. Place of posting:- New Delhi.

8. Period of deputation:- Period of deputation (ISTC) including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of the Central Government shall ordinarily not exceed 4 years.

9. Duties and responsibilities attached to the post:-

- (i) To initiate, guide and coordinate investigations and necessary survey on soil and water conservation relating to agriculture production.
- (ii) To advice on planning of surveys relating to land use, soil conservation, soil classification and nomenclature etc.
