It may also be confirmed that in the event of selection the officer will be relieved of his duties. 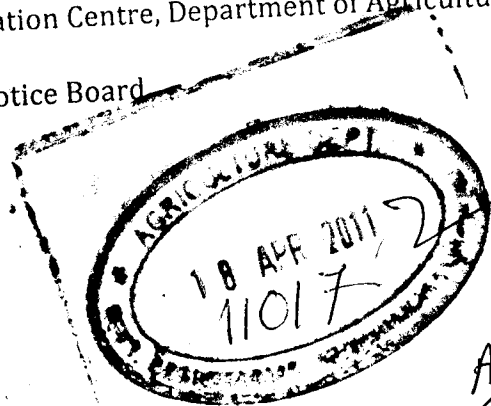
