The candidates noted in the annexure to this order are advised by the Kerala Public Service Commission for appointment to the post of Agricultural Officers on Rs 20740-36140 in the department (NCA ST) They are appointed as Agricultural Officers and allotted to districts noted against each as shown in the annexure and the Principal Agricultural Officers concerned will allow them to be posted in the existing vacancies in the district

The advice of the candidates are subject to Rule 3(c) of the General Rules of the Kerala State and Subordinate Rules 1958 The appointment is temporary under Rule 9(a) 1 of the General Rules as provided under Rule 10 of these rules

The candidates should report for duty before the Principal Agricultural Officers concerned within 15 days on receipt of the posting orders Candidates should produce a Medical Certificate obtaining not below the rank of a Civil Surgeon as provided under Rule 13 of part I KSR and original certificate to prove Date of Birth Qualification and Community at the time of joining duty The Principal Agricultural Officer will verify the original certificates with reference to the details shown in the Public Service Commission advice letter copy of which is enclosed The identity of candidates will be verified with reference to identification certificates enclosed and the fact recorded therein An attestation form in the prescribed format should be got filled up by the candidates before he/she is allowed to join duty The attestation form along with the identification certificates will be returned to this office for obtaining police verification report The candidates from whom non creamy layer certificate should be obtained should also be collected at the time of joining duty for verification by the controlling Officer No travelling allowance will be allowed for the journey to join duty

The candidates will be placed on probation from the date of regularisation of appointment for a period 2 years on duty within a continuous period of three years He/she should pass Account Test(Lower) during the probation period Order regularising their temporary appointment /placing on probation will be issued soon on receipt of the police verification report

Application for correction of date of birth if any should be submitted by the candidates within 6 years of their entry in service as stipulated in G.O(P)46/51 P&ARD dated 30/12/1991

The Principal Agricultural Officer will forward a detailed report on the date of joining duty of the candidates /verification of other factors mentioned above to this office immediately after the candidates join duty. In case a candidate does not join duty within the time limit allowed the details of that candidate along with the identification certificate should also be forwarded to this office promptly

Since the selection to this post is made from a common select list, the candidates are informed that in the event of discharge from service for want of vacancies they may either re-register their names in the office of the Kerala Public Service Commission from where they were advised and get themselves re-appointment on further advice of Kerala Public Service Commission or they may wait for their turn for re-appointment to the post in the department in case they desire to as probationers, in the post from which they are discharged vide circular memorandum No 3737/Rules 1-92/P&ARD dated 29/3/1990 and G.O.(P) 7/91/P&ARD Dated 15/2/91
