The Accountant General (A&E), Kerala, in the letter referred to above, has informed that all indirect subsidies provided by the State are to be categorized under Implicit Subsidies and to be included in the Appendix II of Finance Accounts of the State for 2015-16 as additional information.

In the circumstances, all Administrative Departments in the Secretariat/Heads of Departments are requested to furnish to this department the details of implicit subsidies provided in the form of tax privileges, writing off or restructuring of tax arrears, providing goods and services from Government below market price, allowing the use of Government land or building for free of cost or at subsidized rates and other indirect subsidies granted by each department during 2015-16, indicating the heads of account, amount, nature of subsidy etc. with in the first week of May 2016.
