**ORDER**

As per the letter 1<sup>st</sup> read above, Government of India have sanctioned a project for reviving paddy cultivation through women labour banks for a total cost of ₹.60.62 Crores under National Rural Livelihood Mission. The funding from Ministry of Rural Development (MoRD) is ₹.30.28 Crores and the balance amount needed for the purpose will be contributed by other local bodies and other Government agencies.

The Kudumbasree Mission has been designated as fund routing agency and the Consortium of Malappuram, Palakkad, Thrissur District Panchayats (COMPT) has been designated as the Programme implementing

agency Government of India has released ₹.7.57 Crores as 1<sup>st</sup> installment for project implementation.

As per Government Order read as 3<sup>rd</sup> paper above, Government have appointed Sri.C.Chandra Babu, Joint Development Commissioner, O/o the Commissioner for Rural Development as Chief Executive Officer of Project Management Unit of Mahila Kisan Sashakthikaran Pariyojana (MKSP) under NRLM Scheme, on additional charge.

The Chief Executive Officer, MKSP in his letter read as 4<sup>th</sup> paper above, requested that the Head Quarters of the Project Management Unit (PMU) has to be set up at Thrissur and for smooth functioning of the PMU, adequate staff have to be provided. As per the Government of India's Guidelines, the total administrative cost of the project should not exceed 5% of the total cost i.e., 60.62 Crores. The Chief Executive Officer has forwarded a proposal for creation of temporary posts of project staff in view of the decision in the State Level Co-ordination Committee meeting held on 15<sup>th</sup> May 2012 and also based on the decision in the review meeting held on 21<sup>st</sup> December 2012 at KILA chaired by Sri.S.M.Vijayanand IAS, Additional Secretary, MoRD.

Government have examined the matter in detail and are pleased to accord sanction for the creation of following temporary posts for Project Management Unit (PMU) with Head Quarters at Thrissur, for reviving paddy cultivation through women labour banks in Malappuram, Palakkad, Thrissur districts by the Consortium of Malappuram, Palakkad and Thrissur district panchayats under Mahila Kisan Sashakthikaran Pariyojana (MKSP), subject to the specific condition that the expenditure on project management should be limited to the outlay on cash support and terminate with the project period.
