The Principal Agricultural Officers concerned should report the date of relieving /the date of joining of the incumbents along with a copy of RTC to this office as well as to the office of the Accountant General (A&E), Kerala, Thiruvananthapuram in due course.

The Principal Agricultural Officers concerned should forward the Service Book (after duly updating all necessary entries), LPC of the incumbents and Gazetted Entitlement Register directly to Accountant General (A&E) Kerala for fixation of pay in the post of Agricultural Field Officer. After obtaining the Service Book from Accountant General (A&E), Thiruvananthapuram the same should be forwarded to this office.
