Sub :- Agriculture Department – Estt. – Promotion / Conversion to the post of Senior Clerk – O.A. No.991/15 filed before the Hon'ble Kerala State Administrative Tribunal – Direction complied with – Provisional list of promotion/Conversion - Orders issued.

ORDER NO. SA (4) 47233/14 DATED 24/11/2015

Based on the directions in Government Letter No.14108/EB/14/AD dated 10/7/2014 and G.O. (Rt.) No. 1584/14/AD dated 28/08/14 the promotions/conversions to the post of Senior Clerk (U.D Clerk) w.e.f 01/04/2006 and subsequently, i.e, upto 3.10.13 have been reviewed and the provisional list of promotion/conversion to the post of Senior Clerk, vide paper read as 1st above, has been issued accordingly.

2. The above list of provisional promotions/conversions and the representations involving the cases of disputes, viz., those related to the cadre strength, the re-assignment of seniority of the inter-district transferees, category changed hands etc. along with the specific remarks of the Director of Agriculture thereon have been submitted to Government, vide *Rule 27B, Part II, KS&SSR* and vide paper read as 2nd above for resolving the cases of disputes remained unsettled and revision. The same is being under consideration of Government.

3. Thereafter the details were called for for filling up the vacancies of Senior Clerks upto 31/10/14 and the details upto 31/10/14 were collected from the District Level Officers and other Officers under the direct control of the Director of Agriculture.

4. Meanwhile an O.A. No. 991/15 has been filed before the Hon'ble Kerala Administrative Tribunal in which prayers were made for filling up the vacancies of senior clerks occurred thereafter but kept unfilled. In the above O.A the Hon'ble Tribunal issued an order dated 04/08/15, vide paper read as 3rd above and directed this office to consider the representations of the applicants within the time limit as directed in the order.

In the above circumstances as per the details collected, the provisional promotions/conversions to the post of Senior Clerk for the period from 01/12/13 to 23/10/14 are ordered herewith, vide Annexure, subject to the following conditions.

1. *This promotion order is purely provisional.*

II. *It is subject to the revision of the seniority of those clerks who are provisionally promoted / converted to the post of Senior Clerk w.e.f 1/4/2006 and subsequently, vide paper read as 1st above and decisions of Government regarding the cadre strength, re-assignment of seniority of the Inter District Transferees, Category Changed Hands etc.*

III. *It is subject to the outcome of the final order in O.A No.1150/15 and O.A No.1436/15 filed before the Hon'ble Kerala Administrative Tribunal in this regard.*

IV. *Any monetary benefit or service benefit on regular basis due to this order shall be allowed to the promotees only after the revision of the seniority by Government or as per the directions of Government sought from this office, vide letter 4th paper above, and regularization of the order.*

5. The controlling officers of the promotees will verify the correctness of the details, viz, date of birth, date of acquisition of test qualification etc. with respect to the original certificates and Service Books of the promotees and a certificate in this regard should be furnished to this office in time .

6. Complaints in this regard if any, along with the supporting documents with the attestation of the controlling officer must reach in this office within one month from the date of issuance of this order without fail. Based on this a modified provisional list of promotion will be issued subsequently.

7. The PAO's concerned will issue necessary orders of posting for those who have been granted category change as Senior Clerks in this order in the existing/next arising vacancy in the district concerned.

8. Among the applicants in the O.A No.991/15, Sri.Amar A R, i.e., the first applicant, has already been promoted as Senior Clerk, vide read paper 1st above and the monetary benefits due to the promotion may be sanctioned to him as per the conditions of above paragraph 4 (III). Smt.Anusha N S i.e., the 4th applicant in the O.A is granted promotion as Senior Clerk w.e.f 30/01/14 (Sl.No.28 of Annexure). The other applicants i.e., Sri.Shibu S P, Smt. Simiya S, Clerks, Directorate of Agriculture (2nd and 3rd applicants respectively) will be considered in subsequent orders of promotion.

9. All PAO's must furnish necessary details called for on or before 10/12/2015 as directed in the letter read as 5th paper above so as to enable this office to issue subsequent promotion orders at the earliest.

10. The Order of the Hon'ble Kerala Administrative Tribunal in O.A No.991/15 vide paper read as 3rd paper above is hereby complied accordingly.

11. This order will be published in the official website of the Director of Agriculture i.e, www.keralaagriculture.gov.in All controlling officers are directed to download and communicate the same to all concerned. No individual copy will be issued from this office. Hence all controlling officers are directed to ensure the receipt of the order by all concerned and a certificate in this regard will be furnished to this office within 15 days from the date of this order.


