Sub: Agriculture Department – Establishment – Seniority list of Agricultural Assistants having B.Sc (Agri) degree with 3 years service – Seniority list finalized – orders issued.

Order No. SE (2) 24461/13 Date: 09-05-2014

As per reference read as 1st paper above Provisional Seniority list of Agricultural Assistants having B.Sc Degree in Agriculture with three years service has been published and circulated among all concerned for obtaining suggestions/Complaints. The suggestions/complaints received in this regard are scrutinized and detailed below.

1. Smt. Susan Thomas (Sl. No. 3) and Sri. Sunil Varghese (Sl. No. 13) have submitted representation vide reference 2nd and 3rd cited above. They argued that the placement given to Sri. P.T. Aji (Sl. No.1) & Sri. M.S. Vimalkumar (Sl. No. 2) are irregular. The contention of Smt. Susan Thomas & Sri. Sunil Varghese is that Sl. No. (1) & (2) have not completed three years of service after their acquisition of B.Sc degree. The G.O(Rt) No. 1342/08/AD dated 10-07-2008 clearly specify that the qualification for the post of Agricultural Officer against quota 2% is B.Sc degree in Agriculture with 3 years of service as Agricultural Assistants. There is no

specification that the Agricultural Assistants should complete 3 years service after their acquiring of B.Sc degree qualification. Sri. P.T. Aji (Sl. No. 1) and Sri. M.S. Vimalkumar (Sl. No.2) entered in service as Agricultural Assistants on 28-02-1995 and 12-02-2001 respectively. Smt.Susan Thomas and Sri. Sunil Varghese entered in service only on 2007. The action of the Director of Agriculture in having placed Sri. P.T. Aji and Sri. M.S. Vimal kumar as Sl. No. 1 and Sl. No 2 in the seniority list is in order and hence no modification is required in the seniority list.

2. As per reference 4th cited it is under stood that Sri. T.S. Anil (Sl. No. 26) joined duty as Agricultural Assistant on 02-03-2007. Even before the declaration of probation he has entered on Leave without allowance for a period from 13-03-2007 to 02-01-2011. His probation has been declared on 03-01-2013. Hence his date of entry in service may be treated as 03-01-2011 and his seniority number reassigned as 2723(a). Necessary modification to that effect has been made in the seniority list.
3. As per reference read as 3rd above Agricultural Officer, Krishi Bhavan Kumbalam has reported that Sri. P.T. Aji has completed probation on the FN of 08-03-1997. Vide reference 6th cited Sri. P.T. Aji has submitted that he is eligible to get promotion to the cadre of Agricultural Officer even before promoting Sri. Prasannakumar & others. Even though Sri. P.T. Aji has obtained B.Sc (Agri) degree certificate from Dr. Bhim Rao Ambedkar University on 2002, his name was not considered for promotion to the cadre of Agricultural Officer due to certain allegation leveled against him. He has under gone a regular course of B.Sc (Agri) without obtaining Government sanction and also by not availing proper leave for study purpose. The Government viewed this as a grave misconduct and vide GO(Rt) No. 1937/13/AD dated 05-11-2013, directed Director of Agriculture to finalize disciplinary action against him. The Director of

Agriculture vide order No. SE(2) 61824/11 dated 06-02-2014 has finalized the disciplinary action by barring one annual increment without cumulative effect for one year. More over the cadre of Agricultural Officer is a selection post and the previous select list had been prepared by Departmental Promotion Committee. Hence Sri. P.T. Aji's request to refix his seniority could not be considered.

In the above circumstances, the provisional seniority list of Agricultural Assistants having B.Sc degree in Agriculture with 3 years service has been finalized incorporating the modifications mentioned above and order issued accordingly.


