Sub:- Agriculture Department –Temporary transfer appointment to the post of Agricultural Officers from the category of Agricultural Assistant having B.Sc Degree in Agriculture – Orders issued.

**ORDER No. SD (1) 26167/2011, DATED: 02.08.2012.**

Government as per the Government order 1<sup>st</sup> read above have apportioned the 15% quota earmarked for qualified Agricultural Assistants for transfer appointment as Agricultural Officer as follows:

1. 13% for Agricultural Assistants with pass in suitability test and 10 years service as Agricultural Assistant.
2. 2% for Agricultural Assistants with B.Sc (Agri) and three years service as Agricultural Assistant.

In the Government order 2<sup>nd</sup> read above, Government have accorded sanction for filling up the vacancies under 13% quota by temporary transfer appointment from the Agricultural Assistants having B.Sc degree in Agriculture with 3 years' service under Rule 9 a (i) of KS & SSR and subject to the decision of WP(C) No. 10924/11 and WP(C)No.23905/11 and on a special condition that these candidates will be reverted back as and when eligible hands under 13% quota become available for transfer appointment.

Under the circumstances, the following 24 Agricultural Assistants having B.Sc degree in Agriculture available in the final seniority list published as per order read as 3<sup>rd</sup> above are provisionally transfer appointed as Agricultural Officers in the Scale of Pay of Rs.20740 – 36140 and posted in the Krishi Bhavans noted against their names.

The transfer appointment of the above Agricultural Assistants are purely provisional under Rule 9 (a) (i) of KS & SSR and also subject to the final decision of the Hon'ble High Court in WP (C) No. 10924/11 and WP(C) No.23905/11. The transfer appointment is temporary on a special condition that the Agricultural Assistants promoted to the post Agricultural Officers will be reverted back as and when eligible hands under 13% quota becomes available for transfer appointment on regular basis.

The Principal Agricultural Officers concerned will relieve the officers immediately on receipt of this order. They will also verify and confirm the qualifications and the Date of Birth of the incumbents with reference to the Service Book and the other original records.

The Principal Agricultural Officers will also obtain a declaration from the incumbents to the effect that they have no objection in reverting back to the post of Agricultural Assistants in the event of Agricultural Assistants under 13% quota who become eligible for transfer appointment are appointed against these vacancies.

The Principal Agricultural Officers will report the date of relief and joining of the incumbents with copy of RTC and declaration as obtained above to the undersigned and the Accountant General (A&E), Thiruvananthapuram in due course. The Service Book of the incumbents will be directly forwarded to the Accountant General (A&E) by the Principal Agricultural Officers for further necessary action.
