The last date for the receipt of tender is 7.03.2013 1PM and tenders will be opened on the same day at 2.30PM in the presence of tenderers or their authorized representatives who may be present. If the tender date happens to be a holiday, the same will be opened on the next working day at the same time and condition. The details of the machineries and equipments are as follows.
