- 10) Successful tender should be execute an agreement in Kerala Stamp paper before supply and have to deposit a security of 5% of tendered amount which is exclusive of EMD already furnished. Security should be in the form of DD in favour of Assistant Director of Agriculture, Biotechnology & Model Floriculture centre, Kazhakuttom, Thiruvananthapuram, Kerala – 695582” payable at SBT Kazhakuttam Branch.
- 11) Supply should be completed within 20 days of receipt of supply order. No other conditions with regard to payment put forth by firm will be considered unless it is expressly accepted by undersigned. In case of reasons beyond the control of the contractor as satisfied by the undersigned, the period of supply can be extended up to a period of 45 days beyond which deduction in payment of cost @1% for delay for every week or part thereof will be affected. If the supply is not affected within the prescribed time, the undersigned is at liberty to purchase equipment form alternative source at the risk and cost of defaulter and the expenditure incurred in excess as a result would be realized from defaulter.
- 12) The rate quoted should be firm from the date of opening of the tender and till up to **31/03/2016**.
- 13) The material supplied should confirm to the standard mentioned in the tender and if it is found substandard, the whole payment will be withheld without any intimation. The supplier should lift the same at their own cost and should replace the same with immediate effect.
- 14) Even if the tenderers are using their own paper for quoting rates, they should submit duly singed original tender form in full (without removing any sheet) with remarks “rates quoted separately” in the respective page of the tender forms.
