The bidder desiring to take part in the bid shall log into

<https://etenders.kerala.gov.in/> and then select tender and initiate payment. Bidders will be directed to the payment gateway page of the State Bank of Travancore. There are two options – (1) State bank of Travancore (SBT Net banking payment) and (2) Payment through NEFT from other banks to the payment gateway of SBT.

For obtaining **digital signature certificate** (DSC) and necessary portal enrolment bidders can visit the website <https://etenders.kerala.gov.in/>

The e-tenders submitted by the competent dealer/manufacturer should definitely contain a scanned and signed copy of the **declaration of product offered** (Annexure III) of the machineries/equipments and accessories intended to supply.

Tenders will be opened in the online presence of such bidders or their authorized representatives who have logged in at the prescribed time of opening. If the date fixed for opening happens to be a holiday or in the case of net failure, the tenders will be opened in the next working day, at the same time.

The tender fee shall be paid only through online payment system -SBT / NEFT.

Scanned copy of the agreement (Annexure II) in the prescribed format in Kerala Stamp paper worth **Rs. 200/-** should be submitted online and the original should reach the undersigned before the time of opening of the e-tender.

The rates should be quoted in Indian currency only.

Details with respect to the e-tender and the details of specifications of the item to be purchased can be obtained from the e-tender website <https://etenders.kerala.gov.in>

The rules and regulations prescribed for e-tenders by the Government of Kerala shall be applicable to this e- tender also.

#### **Special Conditions:**

1. The manufacturers or their authorised dealers are eligible to participate in the tender and necessary documents may be uploaded along with the bid documents.
2. The rates should be quoted separately, for each item. The rate should be inclusive of all taxes, cess, transportation, handling or any other cost of installation/ supply and the bidder has to **supply the items at the location specified in Annexure IV** or as per the direction from the under signed.
3. The bidder should confirm the repair & service facilities, availability of spare parts etc., of the machineries, equipments and accessories supplied by them.
4. A minimum warranty period of two year is to be assured for the machineries/equipments supplied. The AMC there after should be mentioned separately.
5. Authorized test report from competent authority should be attached where ever applicable.
6. The Tender Inviting Authority reserves the right to award the full quantity of supply to any one bidder or distribute the supply to different bidders without assigning

reasons thereof.

7. A scanned copy of preliminary agreement (Annexure II) signed in Kerala stamp paper worth Rs. 200/- should be uploaded along with tender documents.
8. EMD, Cost of Tender form+ VAT should be made as a single payment through online.
9. The successful bidder will have to execute an agreement in stamp paper worth Rs. 200/- in prescribed form and manner and also to furnish the required security amount @ 5% of total quoted amount, within 14 days of the receipt of selection notice.
10. The payment shall be released only after satisfying the qualities and specifications of the machineries/equipments/accessories supplied.
11. Tenders received, incomplete in any respect, such as not providing the full technical details of the product, will be summarily rejected and the decision of the under signed on such matters will be final.
12. The supply should be completed within forty five days on receipt of the supply order.
13. If found necessary, field demonstrations of the machinery shall be done at the cost of the tenderer before the technical/ expert committee constituted for the purpose to finalize the selection and decision of the technical committee will be the final and binding.
14. The specifications of the machinery quoted should match with that mentioned in Annexure I. If exact specification is not available, the nearest specification will be considered.
