As per the reference 3rd cited Government have approved select list of 31 officials for promotion to the cadre of Agricultural Field Officer in the scale of pay of Rs. 18740-500-21240-560-24040-620-27140-680-29860-750-32860-820-33680. After the approval of the above selected list six more Assistant Agricultural Officers have submitted their CR's and the Adhoc DPC held on 20.08.2014 has selected all of them to the promotion of the cadre of Agricultural Field Officer for the year 2014. 
