The Principal Agricultural Officers concerned should forward the Service Book (after duly updating all the necessary entries), LPC of the incumbents with Gazetted Entitlement Register directly to Accountant General (A&E) Kerala for fixation of pay in the prescribed post of Agricultural Field Officer.
