and Smt.Sherin Muller, Agricultural Officer, District Soil Testing
Laboratory was transferred to Krishi Bhavan, Vilavoorkal,
Thiruvananthapuram from District Soil Testing Laboratory, Kollam, vide
Order read 1st above. Accordingly vide Order read 2nd above, Smt.
Kalarani.S, Agricultural Officer is again transferred and posted to Krishi
Bhavan, Panayam.
