Advised by Kerala Public Service Commission, Si.Oommen Thomas, Sri.George Sebastian, and Sri.George Alexander had been appointed as Agricultural Officers in the department vide order 2nd read above. As such they have joined duty in the department on 17.01.1989, 23.01.1989 and 18.01.1989 respectively. Thereafter, they were granted Leave Without Allowance for study purpose in relaxation of Rule 88(ii) Part I KSRs subject to the terms and conditions laid down in GO(P)524/84/Fin dated 18.09.1984.

On expiry of the sanctioned period of Leave Without Allowance they have rejoined duty in the department on 28.08.1989, 16.10.1989 and 14.08.1989 respectively. Accordingly, their seniority was fixed based on their date of rejoining duty in the department after the expiry of the Leave Without Allowance availed by them for higher studies and given proper placement in the final seniority list published as per the order 3rd read above as per the previous therein. The rank No. assigned to them in the final seniority list published as per order read as 3rd paper above is as follows.

The above 3 Agricultural Officers have represented in tune with the benefit extended to Smt.S.Sushama on the basis of the judgment of Hon'ble High Court in WP(c)No.24046/03 and RP No. 693/2009 along with judgment in 6710/92 to reconsider their seniority with effect from the original date of joining duty in service on advice from KPSC. As per the above judgment, effective advice of KPSC is the date for reckoning seniority. The representation of the Agricultural Officers was therefore forwarded to Government for consideration and appropriate orders.

In the government order 4th read above, government have ordered to refix the seniority of Sri.Oommen Thomas, Sri.George Sebastian and Sri.George Alexander Agricultural Officers with effect from the date of effective advice of Kerala Public Service Commission as a special case.

In adherence of the directions contained in the Government Order 4th read above, the seniority of Sri.Oommen Thomas, Sri.George Sebastian and Sri.George Alexander Agricultural Officer are refixed with effect from the effective advice of Kerala Public Service Commission for appointment to the post that is with effect from 17.01.1989, 23.01.1989 and 18.01.1989 respectively and reassigned SL.No.1621 A between SL.No.1621 S.Sathis Babu and SL.No.1622 Bay^b.P.E, SL.No.1623A between SL.No.1623 Vasantha.A and SL.No.1624 Anitha George, SL.No.1644A between SL.No.1644 Jyothish Jacob Cherukara and SL.No.1645 Latha Mary George respectively in the final seniority list published as per order 3rd read
